The Participant identified above ("Participant") desires to participate (as a team member, coach, mentor, judge, or in some other manner) in the FIRST® Robotics Competition, FIRST® Tech Challenge, FIRST® LEGO® League, FIRST® LEGO® League Junior, or another FIRST program (the "Programs"). As a condition of allowing Participant to participate in a Program, For Inspiration and Recognition of Science and Technology ("FIRST") requires that the Participant (by his or her Parent/Guardian if under 18 years of age) agree to the terms of this Consent and Release Agreement.

- 1. Participant (and the Parent/Guardian of a Participant under 18 years of age) understands that participation in the Program will expose Participant to risks of injury including, without limitation, injury from building, lifting, and using electrical/mechanical robots and robot components, using tools, other participants, dancing and other associated activities. Participant (and the Parent/Guardian of a Participant under 18 years of age) understands that FIRST does not select, employ, supervise or otherwise exercise authority or control over the coaches, mentors, and other participants in the Program. Participant, if 18 years of age or older, acknowledges and agrees that he/she is primarily responsible for his/her safety. The Parent/Guardian of a Participant under 18 years of age acknowledges and agrees that the Parent/Guardian is primarily responsible for the Participant's safety and that the Parent/Guardian will monitor, as appropriate considering the age of the Participant and other factors, the Participant's participation in the Program.
2. In consideration for FIRST allowing the Participant to participate in a Program, Participant (and the Parent/Guardian of a Participant under 18 years of age for and on behalf of the Participant and the Parent/Guardian) assumes all risk of such participation and hereby releases FIRST and (except as expressly provided below) all FIRST directors, officers, employees, volunteers, and agents from any and all claims for any injury of any kind to the Participant (and the Parent/Guardian) or other damages that may occur as a result of the Participant's participation in the Program, including without limitation any injuries or other damages that may be caused by the negligence of FIRST or negligence of any FIRST director, officer, employee, volunteer, or agent (including without limitation negligently failing to adequately investigate or screen coaches, mentors, volunteers, etc.), and agrees not to file any lawsuit or otherwise make any claim against FIRST or any FIRST director, officer, employee, volunteer, or agent for any such injury or other damages. The Participant (and the Parent/Guardian of a Participant under 18 years of age) does not hereby release any claims against any individual person who intentionally causes injury to the Participant.
3. Participant (and the Parent/Guardian of a Participant under 18 years of age) understands that photographs, videotapes, and other recordings will be made of participants in the Programs, including the Participant. Participant (and the Parent/Guardian of a Participant under 18 years of age) consents to those photographs, videotapes, and other recordings and the use thereof (i) as part of a record of the Program and (ii) to promote FIRST and the Programs.

Participant (and the Parent/Guardian of a Participant under 18 years of age) has read this document and understands that this Consent and Release Agreement includes a waiver of the right to make injury claims that is intended to be legally binding. 1. BACKGROUND. This is a Consent and Release of Rights ("Release") in favor of IndianaFIRST and its officers, directors, employees, successors, assigns, volunteers and entities ("IndianaFIRST") who are working at the authorization or direction of IndianaFIRST with respect to participation in events and programs officially offered by United States Foundation for the Inspiration and Recognition of Science and Technology ("FIRST") and/or IndianaFIRST, whether organized by FIRST, IndianaFIRST, or by both - (collectively the "FIRST Event(s)") "Participant" (by their Parent/Guardian if under 18 years of age) means any person participating, attending, and/or involved, in any capacity, in a FIRST Event

2. AUTHORIZATION TO REPRODUCE PHYSICAL LIKENESS. (A) I acknowledge that FIRST Events are semi-public events that may be attended by the members of the press, business corporations, and media ("Commercial Guests") not under the control of IndianaFIRST who might photograph or videotape the event. As a matter of practice, IndianaFIRST asks Commercial Guests to comply with the FIRST and IndianaFIRST policy of not printing a Participant's name with his/her picture, and IndianaFIRST asks them not to use Images of Participants for commercial purposes without obtaining specific written permission from the Participant (by their Parent/Guardian if under 18 years of age). (B) In consideration of being allowed to participate in one or more FIRST Events, Participant (by their Parent/Guardian if under 18 years of age) hereby agrees and grants to IndianaFIRST the following: (1) the right to photograph, videotape, or otherwise digitally collect Participant's likeness, voice and sounds (as "Works") during Participant's presence at the FIRST Event(s) and assign and grant all rights in these Works to IndianaFIRST, and (2) the right to use or sublicense these Works and Participant's name, likeness and biography, in IndianaFIRST's discretion, in all media, for the promotion of IndianaFIRST and its mission, program and events.

3. WAIVER AND RELEASE OF ANY FUTURE CLAIMS. (A) There are risks inherent in participating in FIRST Events, including risks in the construction of robots, as well as in working with electrical connections, traveling to and from events, and participating in public competitions. These risks include the risk of bodily harm (including without limitation, death) and property damage or loss. (B) Being fully cognizant of the risks of participating in a FIRST Event, I, the Participant, or if under 18 years of age I, Parent/Guardian, and Participant, hereby assume those risks. Except to the extent due to the gross negligence or willful misconduct of IndianaFIRST, and to the fullest extent permitted by applicable laws, in consideration of being allowed by IndianaFIRST to participate in the FIRST Events, I HEREBY WAIVE AND RELEASE ANY CLAIMS OR CAUSES OF ACTION that I, the Participant, or if under 18 years of age I, Parent/Guardian, or the Participant may now or hereafter have against IndianaFIRST arising in connection with or relating to the participant's participation in any FIRST Event or arising from unofficial IndianaFIRST programs and events offered by others. I, the Participant, or if under 18 years of age I, Parent/Guardian, and the Participant, hold harmless IndianaFIRST, against any and all claims resulting from such participation, including, without limitation, claims for compensation, defamation, or invasion of privacy, or other infringements or violations of personal or property rights of any sort whatsoever.

4. AUTHORIZATION FOR MEDICAL TREATMENT In the event Participant should sustain injuries or illness while involved in a FIRST Event, I, the Participant (or their Parent/Guardian if under 18 years of age), hereby authorize IndianaFIRST to arrange for emergency first aid, medications, and/or hospital treatment.

5. CHOICE OF LAW / CHOICE OF VENUE. This Release shall be binding upon me and my heirs, personal representatives and assigns, and shall be governed by and construed under the laws of the State of Indiana. Any legal action arising out of this Release or the subject matter thereof, shall be brought in Tippecanoe County, Indiana. This Release constitutes the entire agreement among the parties hereto with respect to the subject matter of this Release and supersedes any and all such previous agreements among the parties, whether written or oral.

6. CONFIDENTIALITY. IndianaFIRST strongly believes in the confidentiality of all contact information. IndianaFIRST promises that it will not rent or sell this contact information. However, I, the Participant (or their Parent/Guardian if under 18 years of age), hereby grant to IndianaFIRST the right to use the personal contact information provided here to support and promote IndianaFIRST, and its research, program evaluation, alumni efforts and/or other outreach activities.

7. PROVISIONS FOR INDEMNIFICATION WITH RESPECT TO CLAIMS BY THIRD PARTIES.

- A. Indemnify. I, the Participant (or their Parent/Guardian if under 18 years of age), agree to defend, indemnify, and hold harmless IndianaFIRST and its agents from any and all claims, demands, liabilities, and actions of any type, including all resultant costs and attorneys' fees, on account of injury to any person or property arising out of the use, handling, storage, transportation, possession, processing, application, resale, or any other activity involving IndianaFIRST products. This provision shall not operate to relieve IndianaFIRST from its own negligence, but shall operate to relieve IndianaFIRST from any and all liability to the fullest extent allowed by law, including for its own negligence, when other parties are at fault to some degree as well.
- B. Indemnification. I, the Participant (or their Parent/Guardian if under 18 years of age), agree to indemnify and hold harmless IndianaFIRST from any claim or cause of action (including all expenses and reasonable attorneys' fees) arising from, or in connection with, any allegation that the robotics used in any event involving IndianaFIRST were defective in any respect, or are unreasonably dangerous. I, the Participant (or their Parent/Guardian if under 18 years of age), further agree to indemnify IndianaFIRST from any claim asserted against IndianaFIRST arising from, or in connection with, any allegation of negligence, fault, comparative fault or strict products liability arising from, or in connection with, the goods at use in any such event.

8. SIGNATURE (of Participant if 18 years of age or older or Parent/Guardian if Participant under 18). I, the Participant (or their Parent/Guardian if under 18 years of age), understand that this form involves a release of legal rights. I, the Participant (or their Parent/Guardian if under 18 years of age), hereby consents and agrees to the above.

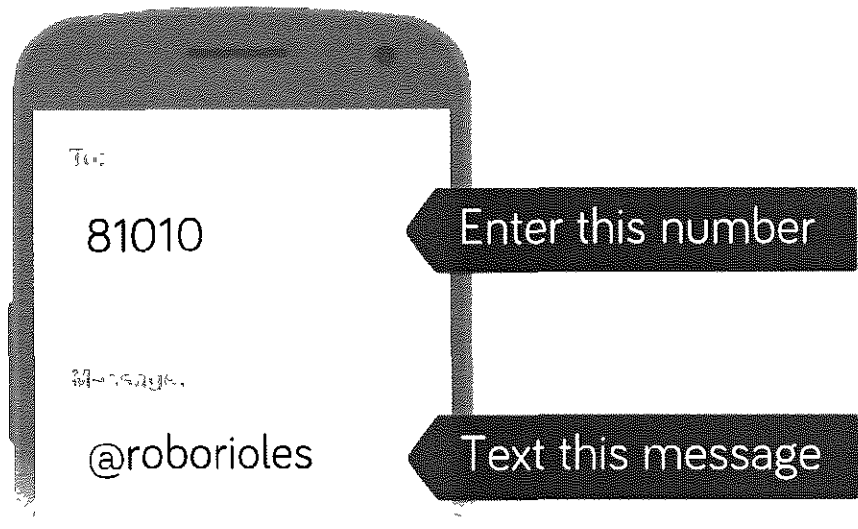

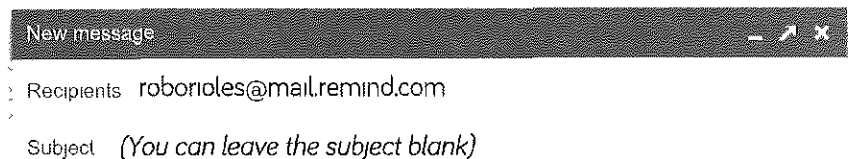
